

## ISSUE OF PLACEMENT SHARES AND CLEANSING STATEMENT

Flexiroam Limited (ASX: FRX) (**Flexiroam** or the **Company**) is pleased to announce that it has completed its placement raising \$2 million (before costs) (refer ASX Announcement of 12 November 2020) through the issue of 86,956,522 fully paid ordinary shares (**New Shares**) at \$0.023 per share to sophisticated and institutional investors (**Placement**).

The Placement was within the Company's existing capacity under ASX Listing Rule 7.1 and 7.1A and the Company has today issued 61,406,697 New Shares under Listing Rule 7.1 and 25,549,825 New Shares under Listing Rule 7.1A.

The funds raised from the Placement will be applied towards the commercialisation and further development for Flexiroam Solutions, an Internet of Things connectivity solutions platform, supporting recovery of its existing data packages and in-app purchases, and general working capital purposes.

An Appendix 2A is attached for the New Shares, which will rank equally with existing fully paid ordinary shares.
